**(Page 2 of 3)**

The granting of this licence is subject to the following conditions:

- 1) 4 Racing (Pty) Ltd shall maintain the Risk Management and Compliance Committee to ensure that 4 Racing (Pty) Ltd does not bring the gambling industry into disrepute by ensuring adherence to the Mpumalanga Gambling Act, Rules, Regulations, licence conditions, approved Internal Control Procedures and this committee, which shall:
  - (a) Maintain the committee charter. A copy of the valid charter must be submitted to the Mpumalanga Economic Regulator, including amendments thereof;
  - (b) Meet a minimum of once every three months; and
  - (c) Submit minutes of its meetings to the Mpumalanga Economic Regulator.
- 2) 4 Racing (Pty) Ltd shall be fully responsible for the correct and accurate functioning of the totalisator, including approval and testing thereof, unless it is supplied and maintained by an appropriately licensed entity.
- 3) 4 Racing (Pty) Ltd shall provide the Mpumalanga Economic Regulator with the following information or copies of documents annually, 6 months prior to renewal of this licence:
  - (a) Financial Statements; and
  - (b) a letter containing a tax compliance status pin.
- 4) 4 Racing (Pty) Ltd shall submit to the Mpumalanga Economic Regulator periodically, as stipulated by the Mpumalanga Economic Regulator from time to time, a deliverable report containing all information required by the Mpumalanga Economic Regulator and in the format approved by the Mpumalanga Economic Regulator.
